Public Hearings

1. Under Section 34 of the Planning Act, a public hearing is being held to consider a proposed Zoning By-law amendment for the following property;

Applicant: Humanity Ontario Gateway

Purpose: The purpose of this Zoning Bylaw Amendment is to rezone the affected

property from the Residential First Density (R1) Zone to the Residential Second Density Special Exception Three (R2-3) Zone in order to permit two proposed semi-detached dwelling units. The exception recognizes a

reduced corner lot area.

2. Under Section 52 of the Planning Act, a public hearing is being held for the purpose of receiving comments on Consent Application;

Applicant: Humanity Ontario Gateway

Purpose: Sever the property to accommodate semi-detached dwelling Location: Adelaide & Oscar St, Merritt Con 5 Lot 8 Plan M173 Lot 36 PCL

11510PT

Zoning: Currently zoned R1 – Residential first density, in addition to this Consent

Application, Zoning Bylaw Amendment Application Z-01/15 has been submitted to rezone the property to R2-3- Residential second density

special exception 3 to permit semi-detached dwellings.

The applicant's agent, Jeff Lapierre was present. Mr. Lapierre stated that he was in attendance to answer any questions and provide any information necessary.

Tara Mokohonuk, local resident, who resides beside the lot being discussed addressed Council, stating that she supports Habitat for Humanity, but does have several concerns should Council allow a semi-detached dwelling to be erected on a small lot. These concerns include the lack of yard space for the family purchasing the home, snow removal issues, lack of space required to erect a wheelchair ramp should one be needed and that the intended use of the property is for a single family dwelling.

Ms. Mokohonuk brought with her a petition with 25 signatures of area residents who opposed the proposed Zoning Bylaw Amendment. All signatures were read aloud.

Mr. Lapierre stated the reason Habitat for Humanity wanted to build a semidetached dwelling was because they had not been able to erect a home for quite some time and wanted to be able to help two families as opposed to one.

Christine MacKay, local resident also voiced her concerns regarding the Bylaw Amendment and the proposed semi-detached dwelling. Ms. MacKay shared the same concerns of her daughter, Ms. Mokohonuk.

Ms. Jill Beer also addressed Council with her concerns with this proposal. Ms. Beer felt that parking would be an issue, she also felt that Council was going against their own policy due to the fact that this property is an R1 Zone and they are considering an exception due to its size.

Written comments were also received by Mr. Bill Olfert who also opposed to the Application.
