**Delegations/Petitions** Lauran Von Valkenburg and Daphne Allen of Save A.B. Ellis (S.A.B.E.) addressed Council concerning the future plans for A.B. Ellis Public School.

> Ms. Von Valkenburg spoke about succession planning and opportunities to draw visitors to Espanola and suggested that the Town request that the Ministry give the building to the Town and the funding that would be used to turn the space into a parking lot be given to the municipality to help offset the cost of creating something such as a Community Hall with seniors housing and perhaps an auditorium.

> Ms. Allen addressed Council explaining that a group of concerned citizens would like to see this building be declared a Heritage Building. She further advised that the group will be meeting later in the week to discuss opportunities on saving A.B. Ellis and stated she would like to have a Municipal Heritage Committee formed. She asked if any Council members would like to volunteer to sit on the Committee. Mayor Piche advised that he will attend the meeting of the S.A.B.E. group later in the week.

> Mayor Piche asked Ms. Allen if she had requested from the school, the report that explains the condition of the building, she stated she had not. Mayor Piche advised that this document would show the reasons why the Ministry has decided to not continue with maintaining the site. Mayor Piche suggested that the total value to turn the building into a site that she has recommended would likely be around 10 million dollars and this was something the municipality was not interested in.

was something the municipality was not interested in. It was also suggested that the group approach Ecole St. Joseph as that site will also be vacant in the near future and may provide a better site for senior housing as it is a newer building, one floor and centrally located.

# Item G3 Childhood Cancer Awareness Month

#### 16-135 R. Duplessis – K. Duplessis

Be It Resolved That: WHEREAS there are about 4,000 children living with cancer in Ontario and each year about 400 new cases are diagnosed; and

WHEREAS the cause of cancer in children is unknown; and WHEREAS 1 in 333 children are diagnosed with a malignant cancer before their 20<sup>th</sup> birthday; and

WHEREAS in Canada, childhood cancer remains responsible for more deaths, from year one through adolescence, than any other disease, killing one in four children affected by this disease; and

WHEREAS childhood cancer crosses all racial, ethnic, and social boundaries; and

WHEREAS an estimated one third of a family's after tax income is spent on treatment related expenses due to lack of available treatment options for the inhabitants of Northern Ontario; and WHEREAS dedicated organizations such as Northern Ontario Families of Children with Cancer and volunteers are working diligently to raise funds in order to improve the lives of Northern Ontario families during and after their journey through childhood cancer by providing essential programs and financial services, and by letting the families know they are not alone in their battle; and

WHEREAS the Town of Espanola recognizes the devastating effects of childhood cancer on the residents of this town; and WHEREAS this month, in the Town of Espanola we pay tribute to the health care professionals, researchers, private philanthropies and parent advocacy groups who collaborate to provide hope and help to patients and families affected by pediatric cancer while making vital contributions to the ongoing search for a cure.

NOW THEREFORE Council for the Town of Espanola hereby proclaims September 2016 in the Town of Espanola as CHILDHOOD CANCER AWARENESS MONTH and encourage residents to show their support for this cause by increasing awareness, speaking up about childhood cancer, wearing the colour gold and reaffirming our commitment to fighting childhood cancer.
