SECTION 1: INTRODUCTION

The Ontario Clean Water Agency (OCWA) acts as the operating authority for the Espanola wastewater treatment. This document is prepared by OCWA in accordance with Environmental Compliance Approval (ECA) #2162-9NYL7Z. The report is required to include the following information:

SECTION 3: Executive Summary

Sampling parameters were **not exceeded** during the 2016 reporting period.

The total effluent discharge from the Sewage Treatment Plant for the year was **1,171,385m³**.

The total raw sewage flow into the Sewage Treatment Plant for the year was calculated to be **1,171,385m³**.



SECTION 4: Process Data

The facility operator collects grab samples of raw sewage and sends them to an accredited laboratory for analysis. Raw flows are calculated using flow meter values.

In addition, the effluent is essentially free of floating and settleable solids and does not contain oil or other substance in amounts sufficient to create a visible film or sheen or foam or discolouration on the receiving waters.



The average flows measured into the sewage treatment plant did not exceed the specified average daily flow of 4500 m³/day in 2016.

The average daily flow for 2016 is 3200.51m³/d which is approximately 71% of the rated capacity. The highest recorded peak flow occurred in December (8,572 m³/d) and was approximately 190% of the average rated capacity, however the peak flow rate specified in the ECA is 12,300 m³/d. The highest recorded flow was 70% of the peak flow rating.

The total raw sewage flow into the Sewage Treatment Plant for the year was calculated to be 1,171,385m³.

The total effluent discharge from the Sewage Treatment Plant for the year was 1,171,385m³.

The average concentrations and loadings for the above parameters were well within the compliance and objective limits specified in the facility ECA. The operator did not observe a visible film, sheen, foam or discolouration on the receiving waters nor did he notice floating or settleable solids.

To ensure objective limits are met, in-house tests are conducted by licensed Operators using Standard Methods. The data generated from these tests are used to determine the treatment efficiency while maintaining process control. All in-house monitoring equipment is calibrated based on the manufacturers recommendations. In 2016, an online pH analyzer was also installed to better monitor the effluent pH.

SECTION 5: Facility Upsets & Non Compliances

During the 2016 year there were no spills, overflows or non compliances.

Minor callouts were mostly due to power failures. There were no process related callouts for the reporting period.

SECTION 6: Maintenance

Plant maintenance is monitored using a Work Management System (WMS). Effluent monitoring equipment was calibrated as required in 2016. Verification records are maintained on site and electronically on the OCWA Hub server. Maintenance and verification reports are attached as Appendix A. Major maintenance is listed in the table below.

A total volume of 2,767m³ was removed from the Espanola WPCP in [2016](#) and was disposed of at the Kelly Lake Biosolids Facility. It is expected that the volume of sludge generated over the next reporting period will be equivalent to the volume generated in [2016](#).

SECTION 9: Additional Information

In 2016, the Espanola WPCP completed a sludge thickening trial with a treatment system designed by Orege. The system uses thickened sludge from the digester and further processes it to remove an even greater volume of water. Polymer is added to the sludge which causes the solids to separate from the water. It is then passed over a series of small grates that allow the water to separate from the solids. The solids then enter a filter box; inside the box is a mesh filter which water can slowly drain through using gravity. Once the filter box is filled the solids are transported to a landfill. The effluent from the process is sent back to the head of the sewage treatment plant where it is mixed with the raw sewage entering the facility.
