Item G5 Municipal Council Support Resolution Notice to Proceed

006 Be It Resolved That: WHEREAS capitalized terms not defined herein have the meanings ascribed to them in the FIT Contract, Version 3.1;

AND WHEREAS the Province's FIT Program encourages the construction and operation of ground mount solar PV, generation projects;

AND WHEREAS one or more Projects may be subject to FIT Contracts and may be constructed and operated in the Town of Espanola;

AND WHEREAS in accordance with the FIT Rules, Version 3.0, the Council of the Local Municipality had previously indicated, by a resolution, its support for Projects in the Local Municipality; AND WHEREAS Council now indicates, by a resolution dated no earlier than June 10, 2015, Council's continued support for the construction and operation of the Projects anywhere suitable in the Local Municipality;

AND WHEREAS, pursuant to the FIT Contract, where a New Resolution is received in respect of the Projects in the Local Municipality, Suppliers will be recognized as fulfilling the requirements under Section 2.4(d)(vii) of the FIT Contract, which may result in Suppliers being offered Notice to Proceed in accordance with the terms of their respective FIT Contract(s); NOW THEREFORE BE IT RESOLVED THAT: Council of the Town of Espanola supports the construction and operation of the Projects where suitable in the Town of Espanola. This resolution's sole purpose is to enable Suppliers to achieve Notice to Proceed under their FIT Contracts and may not be used for the purpose of any other form of municipal approval in relation to a FIT Contract or Project or for any other purpose. This resolution shall expire twelve (12) months after its adoption by Council.

Item G6 Hydro Rates

Be It Resolved That: WHEREAS Council of the Town of Espanola are in agreement that the increases to hydro rates will impose undue hardship on both residents and commercial businesses in northern areas having no access to alternate energy sources, such as natural gas;

AND WHEREAS Council sent a resolution to the Premier of Ontario, the Minister of Finance, the Minister of Energy, area MPPS, and the Association of Municipalities of Ontario (AMO); opposing the privatization of Hydro One in order to keep the service accountable to the public;

THEREFORE BE IT RESOLVED that the Municipality of the Town of Espanola call upon the provincial government to recognize the plight of northern and rural Ontario residents who are directly impacted by the rate increases and the economic ramifications on rural communities as residents are forced to

leave their homes and close their businesses due to

unsustainable hydro rate increases; and

BE IT FURTHER RESOLVED that a copy of this resolution be forwarded to all municipalities in the District of Sudbury in order to encourage other northern Ontario municipalities to request the provincial government to address the financial burden faced by residents and businesses due to increasing hydro rates; AND BE IT FURTHER RESOLVED that the Municipality of the Town of Espanola communicate this resolution to the Premier, with copies to the Minister of Finance, the Minister of Energy, area MPPs, the Association of Municipalities of Ontario (AMO) and the Federation of Northern Ontario Municipalities (FONOM).
