Delegations/Petitions

Dennis Lendrum of Autism Awareness addressed Council with regards to the proposed Autism Awareness Park. He advised Council that he held a site meeting at the green space on the west side of the track and field property to find out if there was support for an Autism Awareness Tree Park at this location. Mr. Lendrum advised that he has obtained 143 signatures in support of this project and a number of local groups and businesses in the community have approach him expressing interest in partnering in the development of this project. Mr. Lendrum advised that there were also some concerns expressed with regard to the proposed site. A number of options were discussed with respect to how to reach out to the community, how to address concerns and opposition to the project.

Council directed Staff to schedule a public consultation at the Complex, notify community groups, leisure partners and residents in order to obtain feedback on the proposed location and park. Staff and Mr. Lendrum are to be present in order to receive and possibly address any concerns that may be expressed. Once that public consultation has been held, Staff is to report back to Council.

Item G5 Hydro One

Be It Resolved That: WHEREAS the public electricity system in Ontario is a critical asset to the economy and vital to the living standard and well-being of all Ontarians;

AND WHEREAS it is essential that Ontarians maintain public control and public decision-making with respect to electricity; AND WHEREAS experience in other jurisdictions shows that privatization typically means consumers pay more for electricity;

AND WHEREAS a privatized Hydro One will no longer be subject to scrutiny by the Auditor General, the Ombudsman, the Financial Accountability Officer, or the Integrity Commissioner, and will no longer be required to provide information or services to citizens under the Freedom of Information and Protection of Privacy Act, the Public Sector Disclosure Act, or the French Language Services Act; AND WHEREAS our public electricity system currently generates hundreds of millions of dollars in revenue for the provincial government every year to help pay for public services we all depend on;

AND WHEREAS the sale of shares in Hydro One will provide a short-term financial gain for the province in exchange for a much larger long-term financial loss;

AND WHEREAS the provincial government has no mandate from voters to sell any part of Hydro One;

AND WHEREAS opinion polls show Ontarians oppose the

privatization of Hydro One by a significant margin in every part of the province;

THEREFORE BE IT RESOLVED that the Municipality of the Town of Espanola call on the provincial government to:

- Halt the sale of any part of Hydro One, and maintain Hydro One as a public asset for the benefit of all Ontarians;
- 2. Strengthen Hydro One by investing in the next generation of workers and upgrading our electricity transmission infrastructure;
- 3. Respect the autonomy and local decision-making powers of local distribution companies by not forcing these companies into mergers or sales;

AND BE IT FURTHER RESOLVED that the Municipality of the Town of Espanola communicate this resolution to the Premier, with copies to the Minister of Finance, the Minister of Energy, area MPPs, and the Association of Municipalities of Ontario (AMO);

AND BE IT FURTHER RESOLVED that the Municipality of the Town of Espanola work through AMO to encourage other Ontario municipalise to express their opposition of the privatization of Hydro One.
